Background

- 1. Over the autumn and winter period we have undertaken a further round of appointments and reappointments to the statutory committees.
- 2. The recommendations on appointments are set out below.

Discussion

Reappointments

- 3. Two members of the Investigating Committee, two members of the Professional Conduct/Health Committees and one member of the Audit Committee are due to complete their initial four year terms on 31 March 2018.
- 4. All but one member sought reappointment. The reappointment applications and recent performance reviews were reviewed by the Chair of Council. All are recommended for reappointment.

Panel Chair appointments

- 5. In order to ensure smooth running of the fitness to practise committees, the Remuneration and Appointments Committee agreed to a process to increase the number of available Panel Chairs.
- 6. Expressions of interest were sought from existing lay members and the individual applicants were interviewed by the Chair of Council. The views of the existing Committee Chairs were also sought.
- 7. The Chair of Council is recommending the appointment of two new IC Panel Chairs and one new PCC/HC Panel Chair.

Lay and registrant PCC/HC members

- 8. A major recruitment exercise was undertaken for PCC/HC members in 2016-17. This year it was decided to further increase the pool of available panellists by increasing the numbers to the maximum allowable number which is 18.
- 9. In the previous applicant process there was a large number of lay applicants and a more than sufficient number of appointable candidates. Therefore the Remuneration and Appointments Committee agreed to re-interview previously appointable candidates for the current vacancies.
- 10. Interviews were held by Ian Muir, independent member of the Remuneration and Appointments Committee on 9 January and two individuals are recommended for appointment.
- 11. The registrant vacancies were advertised on the GOsC website, in the Osteopath magazine and GOsC ebulletin, with further support from the Institute of Osteopathy who highlighted the vacancies in their magazine and e-bulletin.

- 12. There were 18 applications. Interviews were held on 10 January with a panel comprising Ian Muir, independent member of the Remuneration and Appointments Committee, Richard Davies, chair of the PCC, and Deborah Smith, registrant member of Council. Two individuals are recommended for appointment.
- 13. For all but one of the PCC/HC appointments it is recommended that these take effect immediately with the initial appointments taking place for a period of 3 years and 2 months until 31 March 2021 to make them coterminous with other appointments. The final lay appointment is recommended from 1 April 2018 until 31 March 2022 to ensure that the Committees do not exceed their statutory maximum size of 18 members.

Nora Nanayakkara
