Background

1. This work plan update provides the Committee with an overview of project milestones to deliver the aspects of the GOsC's Corporate Plan and Business Plan 2012-2013 falling within its remit. Updates are also provided to each Council Meeting against the current Business Plan as part of the Chief Executive's report.

Discussion

2. All projects currently enjoy Green status except for the projects outlined below.

Guidance for Osteopathic Pre-registration Education

3. As reported at the last Education Committee meeting, the Guidance for Osteopathic Pre-registration Education Working Group met on 8 November 2012. It has agreed to develop a draft set of standards and outcomes based on the work of the other regulators as a starting point to support the group to identify the key issues for discussion drawing on research and publications in other areas. A first draft will be considered by the group when they meet again in March 2013. This work will be considered further by the new Education, Standards and Registration Committee in May 2013.

Recognised qualification processes and quality assurance

4. The deadline for the Annual Reports was 29 January 2013 which has allowed insufficient time for a full analysis ahead of this February 2013 Committee. The analysis of the Annual Reports will, therefore, be considered at the first meeting of the Education, Standards and Registration Committee in May.

Review of Quality Assurance of education and training.

- 5. At its last meeting, the Education Committee requested that a formal consultation was not published at this stage, but that informal feedback from the OEIs about the issues that they would like to see feature in the review should be undertaken along with informal engagement with other regulators. Since then, the Professional Standards Manager facilitated a seminar on this issue with the OEIs on 29 January 2013 and has taken the opportunity to observe an RQ visit to collect further information to inform a major review. Meetings planned with other regulators will take place in spring 2013.
- 6. These changes will all be reflected in the 2013/2014 Business Plan which will be overseen by Council.
