As part of the independent evaluation of the revalidation scheme, KPMG is keen to explore osteopathic patients' views about the need for practitioners to keep up to date. We know from previous surveys undertaken by the <u>General Medical Council</u> and the <u>General Dental</u> <u>Council</u> that the general public expects doctors and dentists to keep up to date. However, we would like to know if osteopathic patients' views are the same.

Following on from last month's update on what other pilot participants have been up to, we heard from Greg Guillon, an osteopath in Chiswick.

Greg told us that he "found the patient's feedback questionnaire –the CARE measure – a really interesting tool to use which provided me

with objective evidence on my practice. Although the design and data analysis can sometimes make you feel like doing your dissertation again (depending when you graduated!), it is great to work on/with a piece of evidence which is objective and comes directly from your patients.

"As the design and set-up is done, I am thinking of using the CARE measure as a form of patient feedback again later this year to have a second 'snap shot' of what I'm doing well and potential areas for development required in my practice."

Good luck Greg, we look forward to hearing how you get on with your next pieces of evidence.
