Case progression – at a glance


- The number of complaints has decreased (14) compared to the previous quarter and is slightly lower in comparison to the number of concerns received in Q3 2020-2021 (18 concerns).
- The IC met remotely on four occasions and considered 11 cases. This represents a 50% increase in the number meetings convened and the number of cases considered in Q2 (2021-2022). All 11 cases were considered and concluded by the IC.
- There are 23 cases that have been referred to the IC by screeners but not yet considered. Nine of the cases (39%) at the IC stage were referred to the IC in Q3. We already have two IC meetings scheduled for Q4 and we are actively considering scheduling more during this period.
- The number of live cases older than 52 weeks has decreased as 3 cases in this category have concluded during this quarter.
- In this quarter the PCC sat remotely for 6 substantive hearings, reaching a final determination in five cases, with 1 being adjourned on the first day of the hearing because a panellist had to withdraw at the last moment due to a family member's health.
- Remote hearings continue to take significantly longer to conclude, despite scheduling longer time to take account of this. This is exacerbated by hearing days generally starting later and finishing earlier.
- In this quarter the HC considered no cases.
- There are 18 cases referred to the PCC by the IC. The breakdown of these 18 cases are as follows: 4 have been listed for hearing; 2 (linked cases) are part heard and awaiting relisting; 4 cases we are awaiting a third party (police) investigation to conclude before we can progress further and/or list the hearing and 8 cases need to be listed, 7 of which were referred to the PCC in Q3.





Investigating Committee

- The IC met remotely on four occasions and considered 11 cases. This is double the number of meetings and cases considered from those considered in Q2. All 11 cases were considered and concluded by the IC.
- The total number of cases at the IC stage is currently 23. It should be noted that 39% of these (9 cases) were referred during Q3 2021-2022. In a further 2 cases we are awaiting the conclusion of a police investigation. We also will schedule future additional IC meetings as we did in Q3.



Professional Conduct Committee

- In this quarter the PCC sat remotely for 5 substantive hearings, reaching a final determination in five cases, with a further case being adjourned on the first day of the reconvened hearing due to matters beyond our control.
- The trend continues in that we find that remote hearings take longer to conclude, despite scheduling longer time to take account of this. This is not assisted by hearing days generally starting later and finishing earlier than planned.
- We have found that hearings conducted remotely take additional time to complete due to numerous factors such as the impact of technical or internet connection issues, a practice of starting later and finishing earlier with frequent, longer breaks. We have also noted that in camera discussions by Panels generally take longer than in person hearings, but this may also be due to the finalising of written reasons by Panels and the developments within case law requiring more detailed reasoning. Initially, without prior experience of running remote hearings, it was challenging to accurately estimate how much additional time would be necessary. Our learning in this has increased by taking account of outcomes within both our own hearings and across the sector.


- There have been two IC Interim Order hearings held in this quarter and two PCC ISO hearings (one of which consisted of two individual cases).
- One of the IC ISO cases applications was complex, requiring an in-person hearing. This has impacted on the median time to IC decision from receipt of referral for this quarter.


