Case progression – at a glance


- We have received 17 new concerns during the reporting period, an increase of two cases since the previous quarter.



 seriously ill the day before the hearing.



Professional Conduct Committee

- During the reporting period the PCC held one PCC substantive hearing and decided to refer the matter to the Health Committee.
- There are currently 18 cases at the PCC stage, the breakdown of which as follows:
 - Three are scheduled for a hearing.
 - Four cases were referred to the PCC in Q3 (the reporting period) and so we are working towards preparing them for service in accordance with our standard case directions, before scheduling for a hearing.
 - o In three complex cases we are looking to serve the case on the registrant before we can schedule for a hearing.
 - One case is currently under investigation by the police and we cannot progress this until the outcome of the investigation.
 - We are working to schedule the remaining seven cases (of which 4 cases relate to a single registrant). Another of which is particularly complex due to numerous witnesses being involved.
 - We are also looking to schedule one case for hearing before the Health Committee.


