

## Council 20 July 2021 London College of Osteopathic Medicine: Recognised Qualification expiry date extension

Classification	Public
Purpose	For decision
Issue	To agree an extension of the current London College of Osteopathic Medicine (LCOM) RQ expiry date from 16 July 2022 to 16 July 2023.
Recommendation	To agree to extend the expiry date of the RQ LCOM programme from 16 July 2022 to 16 July 2023 and seek the approval of the Privy Council.
Financial and resourcing implications	None in relation to the extension of the expiry date. The costs of the RQ review will be budgeted for within the 2021-22 financial year are incorporated into our current contract with Mott MacDonald at a cost of £14,305.
	It may be that the expense is carried over to financial year 2022-23, depending on when the review takes place.
Equality and diversity implications	Equality and diversity issues are explored as part of the RQ renewal process and are explicitly referenced as part of the review criteria set out in the <u>Interim Quality Assurance</u> <u>Handbook</u> . There are no specific equality and diversity issues in relation to the extension of the expiry date.

## Key messages from the paper

- This paper sets out a proposal for addressing the fact that LCOM has no current cohort of students and the impact of this on the planned Recognised Qualification (RQ) review visit.
- It is recommended that the current RQ expiry date of 16 July 2022 be extended by one year to 16 July 2023.
- This approach was recommended by the Policy and Education Committee at its meeting of 29 June 2021.
- Privy Council approval to extend the RQ expiry date will be required.

## Background

- 1. The London College of Osteopathic Medicine (LCOM) currently provides the Member of LCOM qualification which is due to expire on 16 July 2022.
- 2. The last Recognised Qualification (RQ) Visit took place in December 2018 and the Policy and Education Committee (PEC) agreed to recommend to Council renewal of the RQ for a shorter period of three years with specific Conditions.
- 3. This recommendation was agreed by Council at its meeting on 17 July 2020 and the Member of LCOM programme received Privy Council approval on 29 October 2019.
- 4. In order to renew the recognition of the qualification before it expires, a GOsC RQ Review should commence in July 2021, and had been planned in accordance with this timetable. The RQ specification was agreed by the PEC at a meeting on 7 December 2020.

## Discussion

- 5. An RQ renewal visit had been arranged for July 2021, however, LCOM have faced issues with recruitment due to the coronavirus pandemic, and its Trustees have now agreed to delay the commencement of a new cohort until at least September 2021. A visit is not going to meet the RQ specification agreed by the PEC unless there are students in place.
- 6. With the current expiry date, an RQ visitors report would need to be considered by the March 2022 PEC, in order (assuming a recommendation is made to renew), for this to be agreed by the May 2022 Council meeting. Privy Council approval would then be sought to approve the recognition of the renewal, meaning there is no hiatus in the RQ status.
- 7. If a student cohort commences in September 2021, it would be technically possible to undertake a review visit in October/early November 2021, and still meet the March PEC and May Council deadlines. However, the first part of the

programme is distance learning, which would still provide issues in terms of classroom and clinic observation, even if there was a September cohort.

- 8. This issue was reported to the PEC at its meeting of 29 June 2021. The possibility was considered that students commence after November 2021 and the Visit would need to be scheduled from January 2022 onwards. This option would mean that the RQ would expire in July 2022 as the visit report and process would not be concluded before the end of the expiry date. This has an impact for the qualification and the institution.
- 9. As a contingency for such a scenario, we explored the possibility of asking Privy Council to extend the current RQ expiry date by a year, from 16 July 2022 to 16 July 2023. This option has never been undertaken before, but is not, prohibited under the terms of The Osteopaths Act. An extension is not specifically referenced in the Act, but nor is it excluded.
- 10. We raised this option with the Department of Health and Social Care, and it has been indicated that a request to delay the expiry date is possible and there are no immediate concerns with this suggestion.
- 11. Extending the expiry date of the RQ by a year would offer a pragmatic solution which enables LCOM time to recruit a new cohort, and enables an RQ visit to be delayed until the cohort has started and is undergoing face to face teaching and clinical work. This ensures the RQ specification can be effectively fulfilled.
- 12. The PEC agreed with this proposal, and agreed to recommend to Council that it should extend the expiry date of the RQ LCOM programme from 16 July 2022 to 16 July 2023 and seek the approval of the Privy Council.
