
Fitness to practise dashboard 01 April 2021 to 30 June 2021 (Q1)

Case progression – at a glance

- The number of complaints received has remained steady and compares with the previous quarter.
- The IC met remotely on two occasions in this quarter. It considered 4 cases of which two were closed and two referred to the PCC. This is a lower number than average and we are having to schedule an additional IC meeting in August 2021.
- There are 14 cases that have been referred to the IC by the screeners but not
 yet considered. Although there are 14 cases recorded at this stage, an additional
 IC meeting in August has been scheduled to ensure that cases are considered
 without further delay. Two of the cases we are awaiting police investigation to
 conclude and the remaining cases have only recently be referred by screeners in
 the last month.
- The number of live cases older than 52 weeks has reduced to nine cases.
- In this quarter, the PCC sat remotely for 4 substantive hearings, reaching a final
 determination in two cases, with two cases being part heard. This was due to IT
 difficulties in respect of all case parties and a complexity, submitted by the
 defence, that arose regarding our remote hearings platform 'CaseLines' a
 complexity that could not have been anticipated.
- In this quarter the HC considered no cases.
- There are 16 cases referred to the PCC, 8 of which have been scheduled for hearing.
- A member of the Regulation Team has now left the GOsC towards the end of this quarter and so the recruitment process will be starting imminently.



New Referrals

- The number of referrals received in Q1, 20 in total, has remained similar to the previous quarter. This figure, it is noted, is comparable to the referrals received in Q1 in 2020, before the pandemic started.
- The number of cases closed under the Initial Closure Procedure (ICP) has reduced significantly over the last quarter. This is reflective of the high number of cases considered by screeners in the previous quarter (the highest in recent years) which in turn assisted the overall caseload to decrease at the start of Q1. As a result, significantly less cases were considered by screeners over Q1.

Key Performance Indicators

- The Screener KPI was met for this quarter.
- The IC KPI was not met this quarter. Four cases were considered by the IC in this
 quarter, one of which was impacted by a police investigation and two are older
 cases impacted by the pandemic and difficulties collating investigative
 documentation. Whilst the number of cases considered was lower in this quarter,
 we are now scheduling an additional IC meeting in August 2021 to enable the
 timely consideration of cases.
- The PCC KPI was missed in this quarter. This is due to the continuing impact of
 the postponement of all substantive PCC hearings in Q2 2020 and has had an
 effect on scheduling since. The legacy of this is likely to continue to affect our
 performance against the PCC KPI as we continue to conclude these cases but
 also those newer cases being progressed through the system, of which some
 were affected by the complexities of progressing investigations during a
 pandemic.
- There have been no Interim Order hearings held in this quarter.



• The IC considered and concluded four cases this quarter. Two were referred to the PCC and two were closed with no further action.



Professional Conduct Committee

- In Q1 the PCC considered, and concluded, four substantive cases.
- We have found that hearings conducted remotely take additional time to complete due to factors such as the impact of technical or internet connection issues and the need for more frequent breaks for participants. Initially, without prior experience of running remote hearings, it was challenging to accurately estimate how much additional time would be necessary. This is something we are now better able to estimate.
- The number of hearing days has maintained at a healthy, and steady, figure from Q2 and throughout the pandemic. This is due to the ability to hold remote hearings.


