#### **Case progression – at a glance**


- We have received 23 new concerns during the reporting period, an increase from 15 cases received in the previous quarter.

- During this reporting period the Professional Conduct Committee (PCC) held five hearings with four hearings being concluded.



- The IC also met on one occasion to consider an Interim Suspension Order (ISO) application, where undertakings were excepted by the IC on this occasion.



#### **Professional Conduct Committee**

- During the reporting period there were five PCC substantive hearings (two were Rule 8 meetings).
- The number of cases being considered by the PCC over the reporting period is starting to reflect the number of concerns received during Q3 2022/23 onwards, in which the number of concerns received has gradually increased. Prior to Q3 2022/23 the number of concerns received was consistently lower.
- 22% of cases at the PCC stage are third party cases. Although this has decreased from the previous quarter (40%).
- There are currently 18 cases at the PCC stage a decrease of four from the previous quarter. The breakdown of which as follows:
  - Four cases have been scheduled for a hearing.
  - Two cases are currently under investigation by the police and we cannot progress until the outcome of the investigation.
  - o In six cases we are in the process of serving the case.
  - In two cases we are waiting the Registrants' responses before we can consider listing aheairng
  - In one case which was considered at a Rule 8 meeting at the PCC during this quarterand has been referred for a final hearing.
  - In the remaining three cases, these have been referred to the PCC during the reporting quarter and we are preparing to serve in accordance with the standard case directions.


