Registration activity report - additional statistics - sub analysed for AJW

- 1. The Education and Registration Standards Committee received a registration activity report at its meeting of 27 February 2014 which set out the consolidated results of registration data that had been collected across a two year period between 1 October 2011 and 30 September 2013.
- 2. Members requested that one specific section Removals from the Register be sub-analysed in order for some additional information to be ascertained around the demographics of those who had been removed. This report provides that sub-analysis.
- 3. There were 60 registrants removed from the Register between 1 October 2011 and 30 September 2013. There was an almost equal split between those removed for non-payment of the registration fee and non-compliance with the CPD scheme. The table presented in the original report is provided below:

5. Of those registrants removed from the Register, 87% (52 registrants) are below the age of 50, of which 67% (35 registrants) are below the age of 40.

- 9. The geographical split identifies that 60% (36 registrants) were UK based with 40% (24 registrants) based overseas.
- 10. Looking specifically at the UK registrants, there is no indication that, for example, more people were removed from the south of the UK compared to the north and vice versa. The location of the 36 registrants ranges from London, Devon, Lancashire, Warwickshire and Leicestershire among others.
