Updated Initial Recognition Review Specification for the BCNO Group 7 October 2021

Review Specification

Background

- 1. The BCNO group has requested a review of its Recognised Qualification (RQ) provision. Information follows about the new qualifications to be introduced from September 2022 and the teach out provision.
- 2. The BCNO group has developed a new Integrated Masters in Osteopathy (MOst) programme. It is planned that there will be a four year full time degree which will be run in parallel at two sites in London and Maidstone and a part time degree which will run at the London site initially. It is planned that the first cohort of students will be admitted from 19 September 2022 and will graduate from July 2026. The validator of this programme is the University of Plymouth (current validator of the existing BCOM RQ programme).
- 3. The European School of Osteopathy (ESO) and The British College of Osteopathic Medicine merged from 1 September 2021, maintaining their current two sites and brand identities under a unified governance structure. The new provider is called the BCNO group. Both previous providers delivered existing recognised qualifications which will continue to be taught out in the new BCNO group and structure. The existing programmes are summarised as follows:

Review Specification

- 5. The GOsC request that Mott MacDonald schedule an initial recognition review for visitors to report on the following qualifications:
 - Masters in Osteopathy (M.Ost),
 - BSc (Hons) Osteopathy,
 - BSc (Hons) Osteopathic Medicine validated by Plymouth University,

Taking into account, also, the existing qualifications' provision previously awarded by the BCOM and ESO and from September 2021 to be awarded by BCNO Group namely the:

- Master of Osteopathy and BSc (Hons) Osteopathy (formerly awarded by the ESO)
- Masters in Osteopathy (M.Ost) and Bachelors in Osteopathic Medicine (B.OstMed) (formerly awarded by the BCOM)
- 6. The aim of the GOsC Quality Assurance process is to:
 - Put patient safety and public protection at the heart of all activities
 - Ensure that graduates meet the standards outlined in the Osteopathic Practice Standards
 - Make sure graduates meet the outcomes of the Guidance for Osteopathic Pre-registration Education (2015).
 - Identify good practice and innovation to improve the student and patient experience

- Identify concerns at an early stage and help to resolve them effectively without compromising patient safety or having a detrimental effect on student education
- Identify areas for development or any specific conditions to be imposed upon the course providers to ensure standards continue to be met
- Promote equality and diversity in osteopathic education.
- 7. The format of the review will be based on the <u>interim Mott MacDonald</u>
 <u>Handbook</u>, and the <u>Osteopathic Practice Standards (2019)</u>. Associated guidance will also include the draft Guidance for Osteopathic Pre-registration Education (2021) and the draft Standards for Education and Training 2021.
- 8. The Committee would like to ensure that the following areas are explored:
 - a. How effective governance and management is implemented within the merged institutions operating on two sites, including risk identification and management.
 - b. How consistency is ensured in the learning experience of students based at the BCOM (London) and ESO (Maidstone) campuses and clinics.
 - c. How consistency of teaching staff development and performance review is ensured across both sites.
 - d. How consistency of clinical teaching is assured in the experience of students undertaking the modified attendance BSc programme.
 - e. The Committee is keen to ensure that the experience of students continuing on these programmes as they are taught out is positive and consistent, and that the OPS and GOPRE outcomes continue to be delivered.
 - f. Student recruitment
 - g. Financial stability of the new institution.
