# Background

1. This paper provides Council with an update on several appointment activities.

## Discussion

#### Fitness to practise panellists

- 2. There are currently 32 Fitness to Practise panellist positions (15 members of the Investigating Committee (IC) and 17 members of the Professional Conduct/Health Committee (PCC/HC)), all with differing appointment dates.
- 3. There are eight Fitness to Practise panellists (four IC and four PCC/HC) who are eligible for reappointment from 31 March 2020 for a further four years although there is no automatic right of reappointment for any member.
- 4. To be reappointed all applicants will need to complete a reapplication form. This is considered by the Chair of Council as part of a package of information including feedback from the chair of the respective committee along with a copy of the last completed appraisal form.
- 5. Of the eight individuals, it has been possible to consider six reapplications at this stage. The following individuals are eligible for reappointment and it recommended that Council agrees to reappoint for a period of four years from 1 April 2020 to 31 March 2024:
  - Mark Osborne (PCC)
  - Claire Cheetham (PCC)
  - Morag McKellar (PCC)
  - Jim Hurden (IC)
  - Adam Fiske (IC)
  - Laura Heskins (IC)

## Audit Committee appointment

6. In September 2019, Council received an electronic recommendation to appoint Graham Masters as the independent member of the Audit Committee. His term of office runs from 1 October 2019 to 30 September 2023 and for completeness the decision of Council is recorded in this paper.

## Council and Committee appointments

7. There are a number of other Council and Committee appointment processes underway and this paper summarises the positions of those campaigns.

Appointment of two registrant members of Council	A campaign to appoint two registrant members to Council is currently underway and Council will be kept abreast of how the campaign develops.
Appointment of a lay member of Council	A campaign to appoint a lay member to Council is currently underway and Council will be kept abreast of how the campaign develops.
Appointment of an independent member of the Remuneration and	The term of office for the current independent member of the Remuneration and Appointments Committee (RaAC), Ian Muir, concludes on 31 March 2020.
Appointments Committee	A campaign to appoint his successor will commence from January 2020.
