## **Background**

- 1. The first Quality Assurance Agency for Higher Education (QAA) Subject Benchmark Statement for Osteopathy was published in 2007. - 2. As part of its rolling review of benchmark statements, the QAA is currently reviewing this benchmark statement.
- 3. This paper provides an update about the review and the next steps.

## **Discussion**

- 4. The QAA convened a group of experts from within the osteopathy education sector to undertake an initial review of the existing Benchmark statement.
- 5. The group consists of the following:

- 6. The group met initially on 25 February 2014 and discussed which sections of the current Benchmark statement should be reviewed. The sections were divided between the participants to update and the amendments were considered at a further meeting of 22 May 2014.
- 7. The document will be shared with student and osteopath readers (potentially someone working within the NHS) prior to the group meeting one further time to finalise the benchmark for consultation in summer 2014. The consultation will take place in September 2014.
- 8. The existing QAA Subject Benchmark Statement was previously endorsed by the GOsC Education Committee and incorporated as a reference point within the current Quality Assurance review. The development of the new benchmark statement will be monitored in terms of its relationship to the GOsC Quality Assurance process both as part of the existing framework and after the Quality Assurance Review, as well as its relationship to the Guidance for Osteopathic Pre-Registration Education (GOPRE).
- 9. The intention of the GOPRE is for the provision of guidance about the professional expectations of an osteopath. The QAA Subject Benchmark Statement represents a consensus of the academic community about the academic content of an osteopathy degree. It positions osteopathy within the higher education framework. The consultation on the QAA Subject Benchmark Statement has been planned to take place after the GOPRE consultation to ensure that the two documents can complement each other.
