Background

- Under the general conditions applied to all Recognised Qualifications (RQs), educational institutions must `... inform the Education Committee of the General Council as soon as practicable of any change, or proposed change, *likely to influence the quality of the course leading to the qualification and its delivery* (italics added for emphasis). This is interpreted as changes with a potential or actual impact on the delivery of the *Osteopathic Practice Standards*, maintaining patient safety and public protection.
- 2. At the March 2015 ERSC meeting the Committee agreed to a pilot of a Recognised Qualifications (RQs) Notification of Change process. This is intended to identify changes to RQ provision that are relevant to the Committee and ensure that risks are mitigated, as necessary.
- 3. The Surrey Institute of Osteopathic Medicine (SIOM) has notified the GOsC that they are developing a satellite student clinic within Kingston University's Wellbeing Centre, to commence in September 2015. SIOM has submitted a copy of the RQ Notification of Change form (annexed to this paper) in relation to this planned change.

Discussion

- 4. SIOM's proposal is for RQ students to undertake clinical training (including observation and practice under supervision) within a new satellite clinic. This clinic is part of Kingston University's existing Wellbeing Centre. Kingston University is the validating university for SIOM's degree courses.
- 5. As mentioned above, our focus is on changes with a potential or actual impact on the delivery of the *Osteopathic Practice Standards,* maintaining patient safety and public protection.
- 6. SIOM has one ongoing RQ condition: 'To implement a marketing plan which is linked to forecast student numbers, underpinned by strengthened commitments to ensure that students are gaining the requisite breadth and depth of experience to deliver the OPS and address ways of building relationships with existing patients.' SIOM is requested to report on progress with the implementation plan through its RQ Annual Report.
- 7. The analysis of SIOM's Annual Report 2013-14 was considered by the Education and Registration Standards Committee in March 2015. It was noted that SIOM has reviewed the structure of its clinic and has implemented a number of changes, including the planned development of satellite clinics. Therefore this change can be seen as part of SIOM's enhancements to its delivery of the OPS by broadening its patient base and diversity of student experience.
- 8. SIOM has highlighted no differences in the clinical training planned for this clinic as compared with its current provision. SIOM has confirmed that students will be supervised at this satellite clinic by its existing osteopathic faculty. The ratio of

one clinic tutor to four students would be used; this aligns with the expectations of the osteopathic academic community in the QAA's *Subject Benchmark Statement Osteopathy*.

- 9. The clinic would be subject to monitoring through SIOM's quality assurance processes in common with its existing clinical provision.
- 10. It is suggested that this change does not represent actual risks to SIOM's delivery of the OPS, patient safety and public protection. It is intended to contribute to enhanced diversity of student experience, which forms part of meeting its ongoing RQ condition.

Recommendation: to note the change to SIOM's RQ provision through the introduction of a satellite clinic.
