Background

- Our 2018/19 Business Plan sets out a theme of 'Assuring the quality of osteopathic education and training'. Our core goal as part of this is 'Working with our quality assurance partner and UK osteopathic educational providers to ensure that recognised qualifications are only awarded to students who are able to practise in accordance with the Osteopathic Practice Standards (OPS).'
- 2. One of the activities outlined to contribute to this core goal is: 'Work with the Council of Osteopathic Educational Institutions and educational providers to support the development of osteopathic educators.'

Discussion

- 3. The Council of Osteopathic Educational Institutions have been working with a small steering group including ourselves to develop the idea of an Association of Educators in Osteopathy to support the development of a community of educators in osteopathy.
- 4. A document setting out Purpose, Aims, Methods and Next Steps has been developed and work is proceeding under the Chair of the Steering Group, Dr Kerstin Rolfe who is also Chair of the Council of Osteopathic Educational Institutions.
- 5. The purpose of the Association of Educators in Osteopathy includes:
 - a. Identifying, promoting and disseminating good practice in osteopathic education (including but not limited to development of curricula, assessment, teaching and learning, governance and inclusion of patients) drawing from osteopathic education, but also from health professional education and education more broadly.
 - b. Building a community of educators in osteopathy across osteopathic educational institutions by promoting opportunities for learning and sharing together.
 - c. Supporting the continuing professional development of educators in osteopathy.
 - d. Promoting equality of opportunity and valuing diversity, being accessible and inclusive in the context of the achievement of its purpose, aims, methods and outcomes.
 - e. Supporting the development of knowledge and skills in leadership in osteopathic education.
 - f. Supporting the development of the role of educator (for example as external examiner, quality assurance visitor etc.)
- 6. Whilst this initiative is led by COEI, we are working with the steering group and the Osteopathic Educational Institutions to support the continued development of these aims.
