Purpose	For decision
Issue	The appointment of Visitors for the College of Osteopaths Recognised Qualification Review
Recommendations	To agree to appoint Bob Davies, Ceira Kinch and Marvelle Brown as Visitors for the Bachelor of Osteopathy (BOst Part-time) and Master of Osteopathy (MOst - Part-time-Staffordshire University: last cohort entry 2018/19) and Bachelor of Osteopathy (BOst - Part-time first cohort entry 2019/20)
Financial and resourcing implications	The costs of the review will be budgeted for within the 2021-22 financial year are incorporated into our current contract with Mott MacDonald at a cost of c.£15 000.

Background

1. The College of Osteopaths currently provides the following qualifications which are due to expire on 30 April 2022.

Staffordshire University:

- Bachelor of Osteopathy (BOst Part-time)
- Master of Osteopathy (MOst - Part-time) (last cohort entry 2018/19)

University of Derby

- Bachelor of Osteopathy (BOst - Part-time) (first cohort entry 2019/20)

2. The last RQ visit took place in May 2016 and the Education Committee agreed to recommend renewal of the RQ with specific conditions at its meeting on 13 October 2016 from 1 May 2017 until 30 April 2022. This recommendation was agreed by Council at its meeting on 2 November 2016 and the College's qualifications listed (above) received Privy Council approval on 20 December 2016.
3. In order to renew the recognition of the qualifications before they expire, a GOsC RQ Review should commence in 2021. Before the review is scheduled, the Committee will be asked to approve a team of appropriately qualified Visitors under s12 of the Osteopaths Act 1993. Suitable dates will be agreed with the College of Osteopaths, taking into account the indicative timetable outlined in the review specification at the Annex.
4. This paper asks the Committee to appoint the Education Visitor Team

Discussion

Appointment of Visitors

5. Section 12 of the Osteopaths Act 1993 provides that 'The Education Committee may appoint Visitors to ... report to the Education Committee on the nature and quality of instruction and such other matters as he was required to report on by the Committee.'
6. The Committee are invited to appoint Visitors to participate in the review of the College of Osteopaths qualification as outlined in the RQ Review Specification approved by the Committee at the 07 December 2020 meeting.
7. The visit is scheduled to take place during between Friday 21st – Sunday 23rd May 2021. This will be a Virtual Remote Visit. The proposed Visit Team is:

8. These recommended Visitors are members of Mott MacDonald/GOsC Visitor pool (comprising of lay and osteopaths) administered by Mott MacDonald who undertake selection, training and appraisal of all Visitors on our behalf. All Visitors are scheduled to participated in training delivered by the Mott MacDonald prior to the visit.
9. We have checked that the proposed osteopathic visitors are currently registered. We have also checked the Visit Team with the College of Osteopaths which has confirmed that there are no issues for the Committee to consider in appointing the team. We have noted that two of the team members are current members of the Committee. However, we have also noted that the Visitors are appointed by the Committee to undertake the visit and to report back to the Committee against the review specification. The Visitors are provided with all information from the Committee and so we consider this an appropriate review team. The proposed Visit Team has not declared any conflict in undertaking the review of the College of Osteopaths. There is no known reason why we should not appoint these visitors.

Draft Review Specification for the College of Osteopaths- Renewal of Recognition of Recognised Qualification Review

Background

1. The College of Osteopaths (the College) currently provides the following qualifications which are due to expire on 30 April 2022:
 - a. Bachelor of Osteopathy (BOst - Part-time) – Awarded by Staffordshire University (last cohort entry 2018/19)
 - b. Bachelor of Osteopathy (BOst - Part-time)- Awarded by Derby University. (first cohort entry 2019/20)
2. The College wishes to renew the RQ for these qualifications. A copy of the current Recognised Qualification award and the last Quality Assurance Agency for Higher Education (QAA) Report is attached for information.

Review Specification

3. The GOsC requests that Mott MacDonald schedules a monitoring review for Visitors to report on the following qualifications:
 - a. Bachelor of Osteopathy (BOst - Part-time) and Master of Osteopathy (MOst - Part-time) – Awarded by Staffordshire University
 - b. Bachelor of Osteopathy (BOst - Part-time)- Awarded by Derby University.
4. The aim of the GOsC Quality Assurance process is to:
 - Put patient safety and public protection at the heart of all activities
 - Ensure that graduates meet the standards outlined in the Osteopathic Practice Standards
 - Make sure graduates meet the outcomes of the Guidance for Osteopathic Pre-registration Education (2015).
 - Identify good practice and innovation to improve the student and patient experience
 - Identify concerns at an early stage and help to resolve them effectively without compromising patient safety or having a detrimental effect on student education
 - Identify areas for development or any specific conditions to be imposed upon the course providers to ensure standards continue to be met
 - Promote equality and diversity in osteopathic education.
5. The format of the review will be based on the [interim Mott MacDonald Handbook](#) and the Osteopathic Practice Standards (2019). Associated guidance will also include the Guidance for Osteopathic Pre-registration Education (2015) (<http://www.osteopathy.org.uk/training-and-registration/becoming-an-osteopath/guidance-osteopathic-pre-registration-education/>).

6. In addition to the usual review format for a renewal of recognition review (appropriate to the stage of development of this course), the Committee would like to ensure that the following areas are explored:
- a. The impact of the change of validator from Staffordshire University to the University of Derby, including plans for teaching out the Staffordshire programme to ensure the continuity of teaching and learning and delivery of standards is maintained.
 - b. The implementation of the Derby BOST - Part-time programme, which features a reduction in the length of the course, the number of credits within the programme and reduction in clinical hours compared to the former curriculum.
 - c. The varied learning experience of students based at the Staffordshire, Derby and London campuses and clinics.
 - d. The impact of the Coronavirus pandemic on the delivery of programmes, and the changes and modifications made as a result of this.

Table 1- Outstanding Conditions

CONDITIONS	
a.	The College of Osteopaths must reinforce the awareness and understanding of student practitioners in seeking, articulating and obtaining valid patient consent in line with the Osteopathic Practice Standards. The requirements of this Condition have been fully fulfilled.
b.	The College of Osteopaths must develop and implement an academic misconduct policy to strengthen the understanding, detection and management of plagiarism within assessment. The requirements of this Condition have been fully fulfilled.
c.	The College of Osteopaths must articulate a strategic plan, post 2016, that sets a clear direction for osteopathic education at the College in line with its foundation and that is disseminated to all stakeholders. The requirements of this Condition have been fully fulfilled.
d.	The College of Osteopaths must submit an Annual Report, within a three month period of the date the request was first made, to the Education Committee of the General Council.
e.	<p>The College of Osteopaths must inform the Education Committee of the General Council as soon as practicable, of any change or proposed substantial change likely to influence the quality of the course leading to the qualification and its delivery, including but not limited to:</p> <ul style="list-style-type: none"> a. substantial changes in finance b. substantial changes in management c. changes to the title of the qualification d. changes to the level of the qualification

f.	<p>The College of Osteopaths must comply with the General Council's requirements for the assessment of the osteopathic clinical performance of students and its requirements for monitoring the quality and ensuring the standards of this assessment. These are outlined in the publication: <i>Subject Benchmark Statement: Osteopathy, 2015</i>, Quality Assurance Agency for Higher Education and <i>Guidance for Osteopathic Pre-registration Education, 2015</i>, General Osteopathic Council. The participation of real patients in a real clinical setting must be included in this assessment. Any changes in these requirements will be communicated in writing to the College of Osteopaths giving not less than 9 months notice.</p>

	Areas for development
1	Identify opportunities for raising further the awareness of the distinction between the BOST and MOST with staff and students.
2	Review the effectiveness of the processes used to ensure the consistent delivery of lectures at both sites.
3	Develop further the management of new patients to provide students with the opportunity for providing continued treatment.
4	Develop the use of technology to enhance the learning opportunities available to students.
5	Review the reporting lines within the deliberative committee structure to ensure due consideration is given to annual monitoring documents before final signed off by the Quality Review Board.
