Statutory regulator responsible for setting and maintaining standards of osteopathic education, practice and conduct in the UK.

The GOsC has a statutory duty to regulate and develop osteopathy in the UK.

Core functions are:

- Assuring the quality of osteopathic education and training
- Registering qualified professionals on an annual basis and ensuring their continuing fitness to practise
- Setting and promoting high standards of osteopathic practice and conduct
- Helping patients with complaints or concerns about osteopaths and, where necessary, dealing with

those complaints through fitness to practise procedures
